#### **Access**

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### **Provenance**

#### **Scope and Content**

The materials in FOIA 2010-0793-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2010-0793-F contains forms, letters, lists, memoranda, notes, pamphlets, press releases, and reports. The aggregate Bush Vice Presidential relate to the White House Fellowship program and the President's Commission on White House Fellowships.

Subject matter covered by these records includes the utilization of the Fellowship Program by the Office of the Vice President, details of educational trips taken by the Fellows, administrative particulars regarding application procedures, travel authorizations and vouchers, and receptions given by the Vice President for Fellows. Also included is a report on tax reform proposals compiled by a Fellow.

#### **System of Arrangement**

Records that are responsive to this FOIA request were found in one collection area—Bush Vice Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level; that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Please note that a single asterisk "\*" indicates that the category is entirely processed and open.
