FOIA 2010-1892-S contains memoranda of conversations and telephone conversations between President George H. W. Bush and other Heads of State throughout the world. These files are from the National Security Council.

The Staff and Office Files contain memoranda of conversations and telephone conversations between President George H. W. Bush and other Heads of State throughout the world from January 1992 to January 1993, including President Francois Mitterrand, Chancellor Helmut Kohl, Prime Minister John Blair, President Boris Yeltsin, and Prime Minister Brian Mulroney.

# **System of Arrangement**

Records that are responsive to this FOIA request were found in one collection area—Bush Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
