Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in FOIA 2010-1905-S are a systematic, and all inclusive, body of documents responsive to the topic of the FOIA.

FOIA 2010-1905-S contains materials from agencies and individuals including the United States Information Agency (USIA) which is responsible for the US government's overseas information and cultural programs; the Department of State; the Department of Energy; the Central Intelligence Agency; and the National Security Council.

The National Security Council NSR Files contain Presidential Directives, National Security Reviews, correspondence, memoranda, and publications maintained by individual staff members of the National Security Council Office. The Bush Administration issued thirty National Security Reviews between 1989 and 1993. National Security Reviews address specific issues concerning national security and U.S. foreign policy, and present multiple views from different staff members and agencies regarding specific national security issues.

System of Arrangement

Records that are responsive to this FOIA request are found in one collection area—Bush Presidential Records: National Security Council H-Files—NSR Files. These Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
