### **Scope and Content**

The materials in FOIA 2011-0283-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2011-0283-F contains materials from the Subject Files of David Gompert, who served as senior director for Europe and Eurasia on the staff of the National Security Council from 1990 to 1993.

The Staff and Office Files contain memoranda of conversation detailing meetings between President Bush, his advisors, and heads of state from NATO countries and the former Soviet Union discussing the Middle East peace process, Desert Shield/ Storm, and CFE [Conventional Forces in Europe]; memoranda, cables, and papers related to GATT [General Agreement on Trade and Tariffs] and the Uruguay Round trade negotiations; reports and memoranda pertaining to private investment strategies for post-communist Eastern Europe; contingency reports related to the 1991 attempted Soviet Coup; and correspondence, memoranda, and discussion papers related to the Western European Union's (WEU) relationship with NATO and proposed peacekeeping forces/ missions in Europe.

**(A portion of the records in this request have been closed due to national security restrictions. These records will be added to the request if and when they are released.)**

### **System of Arrangement**

Records that are responsive to this FOIA request were found in one collection area—Bush Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Please note that a single asterisk "\*" indicates that the category is entirely processed and open.
