#### **Scope and Content**

The materials in FOIA 2011-0289-F are a selective, not necessarily all inclusive, body of documents

responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2011-0289-F contains materials from the Country Files of Robert L. Hutchings while serving as the National Security Council's Director for European Affairs (1989-1992).

The Staff and Office Files contain memoranda related to U.S. Information Agency broadcasts and programs in Europe, cables and memoranda pertaining to claims by U.S. citizens regarding property losses in East Germany during the Soviet Era, materials related to treaty ratification with the unified Germany, presidential remarks and proclamations recognizing German reunification, and press releases publicizing the statement by Secretary of State James Baker and German Foreign Minister Hans Dietrich Genscher, the U.S.-German Energy Initiative, and meetings between U.S. and German officials.

#### System of Arrangement

Records that are responsive to this FOIA request were found in one collection area—Bush Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
