The Staff and Office Files contain memoranda, reports, and National Security Council notes related to international events and issues such as German unification, CFE [Conventional Forces in Europe], memoranda of conversation from the President's meetings with foreign heads of state during his European trip of May-June 1989, the demise of the Soviet Union, Tiananmen Square, the Bush-Gorbachev Malta Summit, and the U.S.-U.S.S.R. Ministerial in Jackson Hole, Wyoming. Also included are memoranda and drafts related to President Bush's "Beyond Containment" speech.

(A portion of the records in this request have been closed due to national security restrictions. These records will be added to the request if and when they are released.)

Records that are responsive to this FOIA request were found in one collection area—Bush Presidential Records: Staff and Office Files.
