Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, February 2011. Previously restricted materials are added as they are released.

Scope and Content

The materials in FOIA 2011-0570-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2011-0570-F records are divided among three record groups: Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records. The Bush Presidential Records include correspondence, a memorandum, a report, printed material and video tapes concerning invitations to

President Bush for Straight, Inc. events, urges from the public to help keep Straight, Inc. open, an evaluation of Melvin Sembler's performance as U.S. ambassador to Australia, suggestions for how to handle the drug abuse problem, promotional material from Straight, Inc., video messages from President Bush to and on behalf of Straight, Inc. and a video of Straight, Inc.'s operations.

The Bush Vice Presidential records include correspondence, memoranda, remarks, news clippings, printed material, forms, and a video tape discussing a visit by Vice President Bush to a Straight, Inc. facility in St. Petersburg, Florida, news clippings about Straight, Inc., and promotional material from Straight, Inc. The Quayle Vice Presidential records include material pertaining to a meeting between Vice President Quayle and Ambassador Melvin Sembler.

System of Arrangement

Records that are responsive to this FOIA request were found in five collection areas—Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: WHORM Alphabetical Files; Bush Vice Presidential Records: Staff and Office Files; and Quayle Vice Presidential Records: Staff and Office Files. As policy, WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
