Scope and Content

FOIA 2011-1612-F includes selected records from the files of Michael Boskin, Council of Economic Advisors, and Roger Porter, White House Office of Policy Development, related to energy policy. The documents consist of correspondence, papers and reports, printed material, and publications.

Internal correspondence relates to administrative matters, such as preparation for meetings and requests for concurrence and comments on reports, as well as the delineation the Administration's policy on

energy-related topics including the Clean Air Act, the National Energy Strategy, and alternative fuels. Enclosed papers and reports include a DOE interim report on the development of the National Energy Strategy, an EPA report on implementation of the Clean Air Act, an MIT paper on a gasoline tax, and various papers related to research and development for energy efficiency options, such as alternative fuels.

Printed material consists of newspaper clippings on the National Energy Strategy, alternative fuels, the Clean Air Act, and the UK's energy policy. The publications include government reports (e.g., an NSF report on Large Magnetic Fields, a NASA report on Space Life Sciences, and recommendations from the National Academy of Sciences on Global Environmental Change) and private publications (e.g. a report by the Gas Research Insights group on Energy Supply and Demand in the US, a World Resources Institute report on alternative fuels, and an issue of the *Fuel Reformulation* magazine.)

System of Arrangement

Records that are responsive to this FOIA request were found in the following collection area: Bush Presidential Records: Staff and Office Files. As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area. Staff and Office Files are arranged alphabetically by office.
