#### **Extent**

11 folders

#### **Access**

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### **Provenance**

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

### **Processed By**

## **Scope and Content**

The materials in FOIA 2011-2566-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2011-2566-F contains materials from agencies and individuals including Nicholas F. Brady George Bush. Brady was appointed Senator from New Jersey in 1982, but did not seek election after serving his term. He was appointed to various commissions during the Reagan Administration, before being appointed as Secretary of the Treasury in 1988. He served in this capacity throughout the Bush Administration.

The White House Office of Records Management (WHORM) Alphabetical Files contain routine resume process ticket forms, U.S. mail receipt forms, invitations to events forwarded to President Bush by Brady, thank you letters and related correspondence between the President and Brady, and letters from constituents both criticizing Brady's positions and praising them.

The Staff and Office Files contain newspaper articles about Brady, correspondence regarding honorary positions, letters to and from the Office of Government Ethics outlining Brady's compliance with conflict of interest laws, photographs from events in which Brady participated, press releases announcing Brady as Secretary of the Treasury, presentations consisting of economic briefings to the President, and lists of attendees at events.

The Vice Presidential Name Files and Staff and Office Files consist of notes and letters between Vice President Bush and Brady regarding recommendations for positions, invitations to events, and regrets to invitations.

## **System of Arrangement**

Records that are responsive to this FOIA request were found in four collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical and Vice Presidential Name Files are processed at the document level, whereas Staff and Office Files are processed at the folder level; that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Please note that a single asterisk "\*" indicates that the category is entirely processed and open.
