Access

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, December 2011. Previously restricted materials are added as they are released.

Scope and Content

The materials in FOIA 2011-2567-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2011-2567-F contains materials from agencies and individuals including Alan Greenspan, the Board of Governors of the Federal Reserve System, George H.W. Bush, and the Council of Economic Advisors.

The White House Office of Records Management (WHORM) Alphabetical Files contain Recommendation Routing Ticket forms; letters from constituents both supporting and opposing the reappointment of Alan

Greenspan as Chairman of the Federal Reserve Board; routine correspondence from Greenspan and/or his office asking for photographs to be inscribed, passing along information, and recommending individuals for appointment to office.

The Staff and Office Files contain copies of newspaper articles regarding the economy; charts of economic data; informational memos discussing economic issues; economic policy newsletters from the private sector; public press briefings regarding a variety of issues; and reports on economic issues.

The Office of Vice President Bush Name files and Vice Presidential Staff and Office Files and consist of Speaking Request forms for a meeting with Greenspan; letters from Bush to Greenspan recommending personnel appointments; and thank you notes between Bush and Greenspan.

System of Arrangement

Records that are responsive to this FOIA request were found in four collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Staff and Office Files; and Bush Vice Presidential Records: Name Files. As policy, Staff and Office Files are processed at the folder level; that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.
