Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, March 2012. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in three collection areas—Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Staff and Office Files; and Federal Records. As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Scope and Content

The materials in FOIA 2011-2571-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2011-2571-F contains correspondence, memoranda, and publications maintained by individual White House staff members and offices, Vice President Bush's Task Force for Regulatory Reform and the Office of Consumer Affairs. The files of the Counsels Office and Personnel Office contain mostly documents involving the various appointees to the Federal Reserve Board. The materials found within the Council of Economic Advisors include correspondence from the private sector, policy memoranda and economic performance information. The files from Vice President's Task Force examine current regulations and correspondence containing suggestions or recommendations from various officials. Lastly, the files of Ann Windham Wallace contain speeches, event planning materials and correspondence.
