System of Arrangement

Records that are responsive to this FOIA request were found in one collection areas—Bush Presidential Records: Staff and Office Files. As policy, these files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Scope and Content

The materials in FOIA 2011-2573-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2011-2573-F contains correspondence from academics, private economic research organizations, banking officials, including Federal Reserve Banks and members of Congress regarding economic policy; memoranda to Department of State, Treasury, Commerce, the Office of Science and Technology and other Council of Economic Advisors (CEA) members, including reports to the President; historical information on the International Monetary Group and an overview of the administration's monetary policy; copies of newspaper and journal articles, editorials; professional and academic conference papers; legislation and testimony with legislative committees; and CEA meeting notes, agendas and schedules with accompanying economic projections, calculations, data, productivity reports, various industrial sector projections/schedules, economic performance information, tax analysis, Economic Activity Updates and Statistical Inventory reports.
