Scope and Content

The materials listed in this finding aid are a selective, not necessarily all inclusive, body of documents responsive to several Bush Presidential Library FOIA requests regarding Former Ambassador to Hungary, Mark Palmer. This collection contains Bush Presidential Records.

The **Bush Presidential materials** consist of cover sheets, correspondence, and printed material. Correspondence from U.S. citizens recommends retention of Mark Palmer as Ambassador to Hungary. Also included is correspondence with Hungarian citizens regarding gifts presented to President Bush through Ambassador Palmer. Printed material includes clippings regarding the work of Ambassador Palmer in Hungary.

System of Arrangement

Records that are responsive to this FOIA request were found in Bush Presidential Records: WHORM Subject Files. As policy, WHORM Subject Files are processed at the document level. The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
