Scope and Content

The materials listed in this finding aid are a selective, not necessarily all inclusive, body of documents responsive to Bush Presidential Library FOIA requests regarding Cleto Rodriguez. This collection contains Bush Vice Presidential Records.

The **Bush Vice Presidential materials** consist of correspondence and a biographical sketch. The correspondence includes a congratulatory letter from Cleto Rodriguez to George Bush on his election as Vice President in 1980, a congratulatory letter from George Bush to Cleto Rodriguez for his being honored by the Texas State Rifle Association, and an invitation to George Bush from the Texas State Rifle Association to attend the presentation of the award to Cleto Rodriguez. Also included is a published biographical sketch of Cleto Rodriguez.

System of Arrangement

Records that are responsive to this FOIA request were found in Bush Vice Presidential Records: WHORM Name Files and WHORM Subject Files. As policy, WHORM Files are processed at the document level. The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
