#### **Extent**

#### **Access**

Collection is open to all researchers. Access to Bush Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### **Copyright**

#### **Provenance**

#### **Scope and Content**

The materials in 2012-2327-S are a systematically processed body of documents from the White House Office of Records Management (WHORM) Subject File (VP Bush) category CO006.

These records consist of correspondence and forms. The correspondence consists of a letter from Jim Courter, Member of Congress, expressing regret that Admiral Daniel Murphy had taken a role as advocate and publicist for the communist government of Angola. Included in this correspondence is a routine response letter containing a standard reply from the Vice President stating that Murphy, though a

previous associate, was no longer associated with him in any way and that the public relations firm Murphy was a part of would no longer be representing Angola. The forms consist of the White House correspondence tracking sheets.

**System of Arrangement**

Records that are responsive to this request were found in Bush Vice-Presidential Records: WHORM Subject Files.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
