Scope and Content

The materials in FOIA 2012-3124-S are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA.

FOIA 2012-3124-S contains materials from the files of National Security Council staff member Deborah Lehr.

The Staff and Office Files contain materials consisting of transmittal documents such as profile sheets and referral forms, correspondence from members of Congress and private interest groups related to U.S.-China trade and human rights, cables regarding U.S.-China relations, Bush Administration responses to a questionnaire submitted by U.S. Catholic Conference, routine memoranda, press releases, and reports pertaining to U.S. trade with China and similar documents (including presidential remarks) regarding U.S. sales of F-16 aircraft to Taiwan.

System of Arrangement

Records that are responsive to this FOIA request were found in one collection area—Bush Presidential Records: Staff and Office Files. As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
