Scope and Content

The materials in 2012-3161-S are a systematically processed body of documents from the White House Office of Records Management (WHORM) Subject File category FG006-006, National Security Council. The function of the National Security Council is to advise and assist the President on national security and foreign policy matters, and coordinate these policies among various government agencies.

These records consist of memoranda, correspondence, press releases, talking points, and printed material. Memoranda include standard inter-staff memos on approved presidential activity, scheduling,

and meetings. Memos also include routine legislative referral memos concerning proposed bills, discussion drafts, and legislation daily reports. Correspondence includes requests for meetings or interviews and invitations for George Bush or Brent Scowcroft to attend various events or functions, as well as the standard White House staff response letters. Also included are routine congratulatory letters to George Bush upon his presidential inauguration. Press releases contain announcement of presidential appointments. Talking points consist of suggested remarks for both George Bush and Brent Scowcroft for speaking engagements at such events as the National Young Leaders Conference and the Veterans of Foreign Wars Washington Conference. Printed material consist of a Rand Corporation publication on managing US-Soviet relations, a Harvard Business School working paper on the defense acquisition process, and the 1988 Arms Control Disarmament Agency Annual Report to Congress.

System of Arrangement

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
