Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, October 2012. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in two collection areas—Bush Presidential Records: WHORM Subject Files and Bush Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.

Scope and Content

The materials in FOIA 2012-3211-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2012-3211-F relates to Colombian presidents Virgilio Barco and Cesar Gaviria. These materials consist of correspondence tracking worksheets; disposition sheet forms; and Approved Presidential Activity forms on Gaviria's working visit in 1991. Correspondence includes letters to and from constituents commenting on/giving suggestions for stopping illegal drugs; to and from President and Mrs. Bush regarding gifts and honorary chairmanships of museum exhibitions; and from Congressional leadership regarding trips to show support for anti-narcotic efforts of Colombia. Also included are memoranda regarding gifts to heads of state, honorary chairmanships of art exhibits, and requests for/approval of foreign travel for government officials. Additionally, there are unclassified/decclassified memoranda of conversation (memcons) with world leaders, notes regarding possible cooperation between the First Ladies of the Americas and talking points for press appearances.
