# **System of Arrangement**

Records that are responsive to this FOIA request were found in the Quayle Vice Presidential Records: Staff and Office Files. As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

#### **Scope and Content**

The materials in FOIA 2013-0362-S [1] are the documents maintained by the National Security Affairs Office as Correspondence Files.

These records contain thank you messages and responses from Vice President Quayle to letters sent from private citizens and organizations. This correspondence addresses domestic issues (including immigration, VA healthcare, POW'MIAs, and labor issues) and international issues (including Desert Storm, trade, human rights, foreign aid, and foreign political situations). Also included are responses to this correspondence from various agencies directly concerned with the topic of the correspondence, such as Department of State, Department of Defense, Department of Veterans Affairs, and Department of Justice.
