System of Arrangement

Records that are responsive to this FOIA request were found in the Quayle Vice Presidential Records: Staff and Office Files. As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly

responsive to the subject area.

Scope and Content

The materials in FOIA 2013-0362-S [7] are the documents maintained by the National Security Affairs Office as the Chron File of Nancy Clark and Jon Glassman. These records consist of correspondence, printed material, and speeches filed chronologically.

Correspondence between VP Quayle and congressmen, private organizations, and private citizens is filed chronologically. This correspondence addresses administrative details arranged by the Office of the Vice President, and discusses topics such as Central America, the Gulf Crisis, the Soviet Union, human rights, and trade. The printed material includes magazine articles and newspaper clippings about the VP and op-ed pieces by the VP on human rights. Speeches by President Bush and VP Quayle address Eastern Europe, Latin America, and the Middle East. Also included are speeches by Mrs. Quayle, Secretary James Baker, and President Gorbachev.
