Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### Copyright

#### **Provenance**

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

### **System of Arrangement**

Records that are responsive to this FOIA request were found in the Bush Vice Presidential Records: Staff and Office Files. As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

#### **Scope and Content**

The materials in FOIA 2013-1200-S are correspondence, printed material, remarks, and reports collected and maintained by C. Boyden Gray, legal counsel for Vice President Bush.

Internal OVP correspondence deals with administrative arrangements and provides background information on issues such as foreign affairs, environmental concerns, and the Hatch Act and other regulations for government employees. External correspondence to the Vice President and Boyden Gray from private citizens includes questions from the press and invitations to speak at or participate in various conferences and forums. Also included is correspondence from President Reagan to various senators regarding unemployment and trade.

Printed material contains newspaper clippings and magazine articles forwarded to VP Bush and Boyden Gray on a variety of topics, including Israel, the VP's trip to the Middle East, education, regulatory reform, the Iran-Contra Affair, and the 1980, 1986, and 1988 elections. Remarks include speeches by VP Bush, Secretary Shultz, Senator Gary Hart, and a US district judge. Reports from government agencies and from private organizations address topics such as the VP's Task Force on Combatting Terrorism, the Iran-Contra Affair, election issues, terrorism, and oil imports to the US.
