Provenance

Processed By

Staff Archivists, August 2013. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in the Bush Vice Presidential Records: Staff and Office Files. As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Scope and Content

The materials in FOIA 2013-1201-S are records collected and maintained by Donald P. Gregg, Vice President Bush's National Security Adviser.

These records consist of correspondence, press releases, printed material, remarks, and reports related to Vice President Bush's trip to Japan. Specific topics addressed in the records include trade and export concerns for various agricultural and industrial products, US-Japan trade relations, US-Japan Energy Cooperation, export control, the trade deficit, and competitiveness.
