System of Arrangement

Records that are responsive to this FOIA request were found in the Bush Vice Presidential Records: Staff and Office Files. As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Scope and Content

The materials in FOIA 2013-1204-S are materials collected and maintained by John Schmitz, Deputy Counsel to the Vice President.

The materials consist of correspondence, agenda, minutes, press releases, printed material, remarks and reports related to the Domestic Policy Council (DPC) and to Economic Policy Council (EPC). These documents provide background information and recommendations on issues including deregulation, the domestic oil industry, federalism, emergency planning, insurance, intellectual property rights, rural economic planning, superconductivity, and textile trade policy.
