Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

System of Arrangement

Records that are responsive to this FOIA request were found in the Bush Vice Presidential Records: Staff and Office Files. As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Scope and Content

The materials in FOIA 2013-1206-S consist of correspondence, lists, printed material, remarks, and schedules related to Vice President and Mrs. Bush's travel to China and the Middle East.

Administrative correspondence arranges travel details for the VP and Mrs. Bush, the pre-advance team, and the press corps traveling with the VP. Letters from private citizens invite the VP to speak at/attend conferences and meeting, and provide unsolicited opinions on issues such as the Soviets, Cuba, offshore drilling, and drug trafficking. The lists include summary information on the correspondence sent to the VP while he was traveling, guest lists for VP dinners abroad, and lists of press representatives traveling with the VP. Printed material consists of newspaper clippings about the VP's visit to China, and pamphlets containing tourist information for various stops on the Middle East trip. The remarks by the VP consist of statements made during his trip to China and press conference statements about his China and Middle East trips. Also included are travel schedules for the VP and Mrs. Bush for Saipan, China, and the Middle East.
