System of Arrangement

Records that are responsive to this FOIA request were found in the Bush Vice Presidential Records: Staff and Office Files. As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Scope and Content

The materials in FOIA 2013-1207-S consist of correspondence, lists, meeting minutes, agendas, and papers, created by and for the Cabinet Council on Economic Affairs and for the Cabinet Council on Commerce and Trade, as well as correspondence and travel schedules related to the Vice President's trip to Africa.

Correspondence and issues papers sent to the Cabinet Council on Economic address meeting topics such as wages, credit policy, economy legislation, commodity trading, and employment policy. Correspondence and issues papers addressed to the Cabinet Council on Commerce and Trade provide background on topics including export financing programs, the US automobile industry, steel trade issues, maritime policy, and trade reciprocity.
