Access

Collection is open to all researchers. Access to Bush Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivist, November 2013. Previously restricted materials are added as they are released.

Scope and Content

The materials in FOIA 2013-1208-S are a systematically processed body of documents from the files of John Schmitz, who served as Deputy Counsel to the Vice President. The materials are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. At this time the majority of the records in this request are security classified and have been closed under the restrictions of the Freedom of Information Act.

The documents to be opened include memoranda, correspondence, lists, remarks, and minutes. Memoranda contains mundane distribution and transmittal memos, scheduling and planning meeting

memos, event invitations, and routine meeting agenda memos for the Domestic Policy Council and the Economic Policy Council. Correspondence is regarding citizens writing in to the White House with their policy concerns, and includes the standard staff response letters. List contains public statements, speeches, and toasts given by the Vice President on his European trip. The Vice Presidential remarks were given while visiting Warsaw, Poland. Minutes contain unclassified meeting minutes for the Economic Policy Council.

System of Arrangement

Records that are responsive to this request were found in one collection area—Bush Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
