#### **Extent**

18 folders

#### **Access**

Collection is open to all researchers. Access to Bush Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### Provenance

Official records of George Bush's presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

### **Processed By**

## **Scope and Content**

The materials in FOIA 2013-1210-S are a systematically processed body of documents from the files of Admiral Daniel J. Murphy, who served as Chief of Staff to the Vice President. The materials are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials. At this time the majority of the records in this request are security classified and have been closed under the restrictions of the Freedom of Information Act.

The documents to be opened include memoranda, correspondence, lists, cables, and printed material. Memoranda contain mundane distribution and transmittal memos, as well as information concerning establishment of an inter-agency working group and a Senate drug enforcement caucus trip report. Correspondence consists of Secretary of Transportation and Coast Guard inquiry in regards to Executive Orders 12333 & 12356 and security classification guide relating to international narcotics trafficking. List includes public affairs officers for NNBIS regional headquarters. The unclassified cables contain routine information regarding Coast Guard law enforcement patrol, the establishment of the Vice President's NNBIS Regional Centers, and weekly report from the South Florida Task Force. Published material contains such news articles as Reagan's war on drugs, Florida border checkpoints, and drug seized in Colombian raid.

#### **System of Arrangement**

Records that are responsive to this request were found in one collection area—Bush Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
