#### **Provenance**

Official records of George Bush's presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

# **Scope and Content**

The materials in FOIA 2013-1213-S are a systematically processed body of documents from the subject files of Meredith Armstrong, of the Press Office. The materials are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

The documents to be opened include memoranda, correspondence, press releases, and printed material. Memoranda contain routine White House staff memos to other staff members and to the Vice President on such topics as national drug abuse education and prevention week, public affairs strategy for drug abuse policy, and communication themes for the President's campaign against drug abuse. Also included

are memos regarding working group meetings and scheduling information. Correspondence is in regards to anti-crime legislation, refugee assistance, creation of the Senate Drug Enforcement Caucus, and public concerns on Florida immigration and illegal narcotics. Press releases contain selected quotations regarding drug abuse, drug enforcement accomplishments, National Narcotics Border Interdiction System fact sheet, Vice Presidential remarks at Miami Citizens against Crime luncheon, and a Presidential Statement on the South Florida Task Force. Printed material consists of newspaper articles concerning crime statistics, narcotics trafficking, student drug abuse prevention program, and narcotics seizures and arrests.

# **System of Arrangement**

Records that are responsive to this request were found in one collection area—Bush Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
