## **Scope and Content**

The materials in FOIA 2013-1260-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2013-1260-F contains materials from the files of National Security Council staff member Jane Holl.

The Staff and Office Files contain memcons (memoranda of conversation) between President Bush and foreign heads of state regarding the conflict in Yugoslavia; schedules for the president's meetings with foreign officials and heads of state; memoranda, cables, and reports regarding Cyprus/ Greece/ Turkey; correspondence from Slavic interest groups, private citizens, and U.S. government leaders urging U.S. action to resolve the conflict in Yugoslavia; memoranda discussing U.S. foreign policy towards the emerging independent republics of the former Yugoslavia; polling data reports from the U.S. Information Agency regarding the European public's views toward European integration; and memoranda, reports, and cables pertaining to the UNPROFOR (United Nations Protection Force) mission in the Yugoslav republics.
