Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, July 2013. Previously restricted materials are added as they are released.

Scope and Content

The materials in FOIA 2013-1749-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

This material contains memoranda, correspondence, papers, talking points, printed material, and press releases. Memoranda include standard inter-staff memos on draft organizational documents for the Citizen Democracy Corps, including guidelines, function, and structure. Memos also include routine legislative referral memos concerning foreign assistance bills, discussion drafts, and Agency for International Development Information legislation daily reports. Correspondence includes public mail in support of the Citizens Democracy Corps and standard White House staff response letters. Papers consist of "The Worldwide Trend toward Democratic Capitalism" by Michael Boskin, the 1990 Annual Report of

the National Endowment for Democracy, and the 1992 testimony of Secretary Baker before the Senate Foreign Relations Committee. Talking points are in regards to foreign assistance programs and the economic situation in Eastern Europe. Printed material consist of news articles on the National Endowment for Democracy, compendium of U.S. Nonprofit Assistance to Central and Eastern Europe and the Commonwealth of Independent States Volumes I and II, and a publication from the International Conference from the Center for Democracy. Press releases contain fact sheets on the Citizens Democracy Corps, the 1992 International Affairs Budget, and the 1990 State of the Union address. Also included in the press releases are remarks by the President to the Citizens Democracy Corps conference and the President's address to United Nations General Assembly.

System of Arrangement

Records that are responsive to this FOIA request were found in three collection areas— Bush Presidential Records: WHORM Subject Files, Bush Presidential Records: Staff and Office Files, and Bush Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
