Access

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, May 2014. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in three collection areas—Bush Presidential Records: WHORM Alphabetical File; Bush Presidential Records: WHORM Subject Files; and Bush Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at http://bushlibrary.tamu.edu/research/find/whorm/whorm.html.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.

Scope and Content

The materials in FOIA 2014-0829-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2014-0829-F contains materials regarding the appointment of Mr. Endicott as Counsel General, Department of Veterans Affairs.

The WHORM Files contain copies of required administrative personnel forms, correspondence from Mr. Endicott, including his lengthy and detailed resume, to Chase Untermeyer, Director of Personnel, and letters of recommendation from prominent U.S. Congressmen. Staff and Office Files contain letters requesting Endicott to complete required documentation to assist in his background investigation as well as the nomination from President Bush to the U.S. Senate.
