System of Arrangement

Records for this systematic project were found in the following collection area— Bush Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.

Scope and Content

The materials in Case Number 2014-0869-S are a systematically processed body of documents responsive to the topic. Researchers should consult the archivist about related materials.

CASE NUMBER 2014-0869-S are a systematically processed body of documents from the files of Randy Beers related to meetings involving the National Security Council. The Staff and Office Files contain cover sheets, correspondence, forms, lists, press releases, printed material, remarks, and reports. These records date from 1989 and are arranged chronologically within the different meeting groups.

It should be noted that a significant number of the documents listed here are security classified and have been closed under the restrictions of the Freedom of Information Act.
