System of Arrangement

Records that are responsive to this systematic request were found in one collection area—Bush Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Scope and Content

The materials in Case Number 2014-0871-S are a systematically processed body of documents from the files of Lorne Craner, Director of Asian Affairs at the National Security Council. The records consist of correspondence, press releases, printed material, reports, and statements. These records relate to relations with Asian countries and the POW/MIA issue in Southeast Asia.

It should be noted that a number of the documents listed here are security classified and have been closed under the restrictions of the Freedom of Information Act.
