Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

System of Arrangement

Records that are responsive to this FOIA request were found in one collection area-Bush Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Scope and Content

The materials in Case Number 2014-0881-S are a systematically processed body of documents from the files of Martha Hill, Deputy Legal Adviser to the National Security Council. The records consist of correspondence, press releases, printed material, reports, and statements. The majority of these records relate to investigations conducted by the Senate Select Committee on POW/MIA Affairs; the Senate Committee on Banking, Housing and Urban Affairs regarding the Banca Nazionale del Lavoro (BNL) case; the Senate Committee on Agriculture, Nutrition, and Forestry; the October Surprise Task Force; and the Iran-Contra Task Force. Other records relate to the 1992 campaign.

It should be noted that a number of the documents listed here are security classified and have been closed under the restrictions of the Freedom of Information Act.
