System of Arrangement

Records that are responsive to this FOIA request were found in one collection area-Bush Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Scope and Content

The materials in FOIA 2014-0887-S are a systematically processed body of documents from the files of James Miskel, Director for Defense Policy and Arms Control at the National Security Council. The records consist of correspondence, printed material, reports, and statements. These records relate to the National Security Telecommunications Advisory Committee, the Advisory Group for Ammonium Perchlorate, security of the National Communications System, emergency preparedness, and sealift.

It should be noted that a number of the documents listed here are security classified and have been closed under the restrictions of the Freedom of Information Act.
