Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, September 2014. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive in this systematic project were found in one collection area—Bush Presidential Records: Staff and Office Files. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Scope and Content

The materials in Case Number 2014-0904-S are a systematically processed body of documents from the files of James McCue, the Director for NSC Security Programs.

CASE NUMBER 2014-0904-S contains records consisting of correspondence, printed material, reports, and statements.

The Staff and Office Files contain records which relate to the creation and implementation of policies and procedures for ensuring that national security information is safeguarded within the offices of the National Security Council.

It should be noted that a significant number of the documents listed here are security classified and have been closed under the restrictions of the Freedom of Information Act.
