**Scope and Content**

The materials in Case Number 2015-0020-S are a systematically processed body of documents from the files of Nicholas Rostow, Special Assistant to the President for National Security Affairs and Legal Adviser to the National Security Council [NSC]. The records consist of correspondence, legal documents, press releases, printed material, remarks, and reports.

These records address legal issues such as accomplishments of the Bush administration, document/information requests, ethics, export controls, human rights, humanitarian aid, immigration, international relations, invitations for President Bush and NSC staff members to speak at professional/private events, legal guidance/representation of NSC employees, litigation against the NSC, military force in Iraq, policy review, POW/MIAs, records management, responses from Executive agencies to proposed legislation, sanctions, and trade.

It should be noted that a significant number of the documents listed here are security classified and have been closed under the restrictions of the Freedom of Information Act.
