The materials in FOIA 2015-0268-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2015-0268-F White House Office of Records Management (WHORM) Alphabetical Files contain letters of correspondence between the years of 1981 and 1993, on subjects such as retirement, thanks, congratulations on speeches, and best wishes. Also included are signed photographs of the President at various events.
