Scope and Content

The materials in FOIA 2015-1461-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2015-1461-F contains materials from the Office of Operations, Administration, and Staff Secretary, Thomas J. Collamore Files. These records relate to remarks that Vice President Bush delivered on June 22, 1988 at the National Sheriff's Association meeting in Louisville, KY.

This Staff and Office File contains the final index cards of proposed remarks utilized by Vice President Bush which include his personal notations, as well as several copies of the cards without notations. In addition, there are numerous copies of press releases which are excerpts of remarks at this event, and fact sheets having to do with criminal justice and law enforcement. Finally, there are two draft copies of the Resolution on the National Narcotics Border Interdiction System (N.N.B.T.S.).

System of Arrangement

Records that are responsive to this FOIA request were found in one collection areas—Bush Vice Presidential Records: Staff and Office Files. As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
