Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, August, 2016. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in three collection areas—Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Staff and Office Files; and Quayle Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at http://bushlibrary.tamu.edu/research/find/whorm/whorm.html.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.

Scope and Content

The materials in FOIA 2016-2519-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2016-2519-F contains materials concerning Federal Express.

The Bush Presidential Staff and Office Files contain correspondence, forms, reports, and publications maintained by individual staff members and offices. There are letters from Federal Express President Frederick W. Smith concerning potential committee appointments. Also included is a brochure and report on the Federal Express Employee Volunteer program. There are also a letter and report concerning proposed family leave legislation. Forms include shipping labels and routing memoranda.

The Bush Vice Presidential Staff and Office Files contain memoranda related to the shipping of a gift received by Mrs. Bush.

The Quayle Vice Presidential Staff and Office Files contain a letter and report concerning the United States Postal Service's planned expansion of its Express Mail venture.
