Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, March 2018. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in five collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Subject Files; and Bush Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly

responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.

Scope and Content

The materials in FOIA 2017-0099-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2017-0099-F contains materials from agencies and individuals concerning New Zealand.

The White House Office of Records Management (WHORM) Alphabetical Files contain letters from individuals on topics such as immigration and children with special needs.

The WHORM Subject File categories contain articles, correspondence, forms, and press releases. There are letters from individuals supporting candidates for the ambassadorship to New Zealand. Additionally, there are letters from Ambassador to New Zealand Della Newman concerning U.S.-New Zealand relations. There are press releases announcing the appointment of individuals to ambassador positions. Articles from New Zealand papers highlight programs attended by Ambassador Newman.

The Staff and Office Files contain correspondence, memoranda, and publications maintained by individual staff members and offices. Included in these records are letters of congratulations to President Bush after the 1988 election. There are also records concerning the nomination of Della Newman as ambassador to New Zealand. Other records include requests for travel from various cabinet and administration officials.
