Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, March 2017. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in one collection area—Bush Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Scope and Content

The materials in FOIA 2017-0310-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

The Staff and Office Files contain correspondence, reports, and publications maintained by individual staff members and offices. The majority of the files are from the White House Counsels Office and contain correspondence between the White House and cabinet officials concerning the development of U.S. global climate change policy. Included among the memoranda are agency reports and papers on topics such as greenhouse gas effects, international agreements on climate change, and economic impacts of climate change. There are also documents concerning the Intergovernmental Panel on Climate Change (IPCC).
