As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Scope and Content

The materials in 2017-0355-S are a systematically processed body of documents created and maintained by Paul Wonnacott, Council of Economic Advisers. These records discuss the economic implications of various domestic issues (e.g. antitrust enforcement, employment, energy strategy, health care, income mobility, inflation, regulation) and international issues (e.g. trade, financial aid).

The Staff and Office Files contain correspondence, press releases, printed material, remarks, reports, and talking points. Internal correspondence provides views on proposed legislation/programs and the national economic outlook. It also addresses domestic and international economic issues such as antitrust enforcement policy, employment, income mobility, international aid, maritime shipping, NAFTA, national energy strategy, quotas, regulatory reform, taxes, technical assistance to Central and Eastern Europe, trade, and the Uruguay Round. Correspondence with Congress and private citizens addresses issues such as import quotas, international aid, foreign investment in the United States, and trade.

White House press releases discuss the benefits and costs of legislative proposals, foreign assistance, trade agreements, the national energy strategy, and the export enhancement program. A joint EC/US press release discusses the Uruguay Round Negotiations. Printed material consists of clippings on issues such as recession, economic forecasting, international aid, trade, income mobility, income distribution, maritime policy, and trade plans. Remarks by Paul Wonnacott address the free trade agreement, recession and recovery, and US economic performance and prospects. Remarks by other administration officials address maritime policy and other economic issues.

Government reports provide information on the state of the US economy, macroeconomic analysis of legislative proposals, dynamic review estimate, antitrust enforcement guidelines, US assistance for Central and Eastern Europe, economic assumptions for amid-session review of the budget, deregulation, and the Enterprise for the Americas Initiative. Reports from private organizations address economic issues such as US manufacturing and shipping legislation. Talking Points discuss topics such as the poverty rate, recession recovery, commercial maritime policy, US-Japan Semiconductor Arrangement, and the economic outlook for the US economy.

These records are divided into three series:
