As policy, Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

Scope and Content

The materials in 2017-0382-S are a systematically processed body of documents created and maintained by John Talor, Council of Economic Advisers.

The Staff and Office Files contain correspondence, briefing books, press releases, printed material, remarks, reports and talking points. These records discuss the economic implications of various domestic issues (e.g. agriculture, inflation, the federal budget, privatization) and international issues (e.g. technical and financial assistance, export controls, free trade agreements, international monetary reform, foreign investment in the US).

These records are divided into four series:
