Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, July 2017. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in three collection areas—Bush Presidential Records: WHORM Subject Files; Bush Vice Presidential Records: Name Files; and Bush Vice Presidential Records: WHORM Subject Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at http://bushlibrary.tamu.edu/research/find/whorm/whorm.html.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.

Scope and Content

The materials in FOIA 2017-0894-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2017-0894-F contains records relating to Mr. Paul Boesch, a Houston wrestling promoter. He was a friend of the Bush family.

The Bush Presidential WHORM Subject File categories contain correspondence between Paul Boesch and President Bush regarding the Inauguration and an autograph request, as well as autograph requests.

The Bush Vice Presidential Name File encompasses correspondence between Paul Boesch and Vice President Bush. Subjects include autograph requests, invitations, general support, and constituent relations.

The Bush Vice Presidential WHORM Subject File categories hold correspondence between Paul Boesch and President Bush. An invitation to a retirement gala for Boesch and thoughts on a speech given by Vice President Bush comprise the topics.
