Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, July 2018. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in five collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Subject Files; and Bush Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents

are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.

Scope and Content

The materials in FOIA 2017-1772-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2017-1772-F contains materials from agencies and individuals concerning the first Secretary of Veterans Affairs, Edward J. Derwinski.

The White House Office of Records Management (WHORM) Alphabetical Files contain letters from the general public offering both praise and criticism of Secretary Derwinski.

The WHORM Subject File categories contain calendars, correspondence, press releases, and reports. There are schedules and calendars concerning weekly cabinet secretaries' activities. There are annual reports on the state of the Department of Veterans Affairs submitted by Secretary Derwinski. There is general correspondence between President Bush and Secretary Derwinski. There are press releases concerning the nomination of Secretary Derwinski.

The Staff and Office Files contain correspondence, reports, and press releases. There is general information concerning the nomination of Edward Derwinski to the position of cabinet secretary. Also included in these files is his resignation letter. There is also included an official biography and photo.
