Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, October 2017. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in five collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Name Files; Bush Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual

documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.

Scope and Content

The materials in FOIA 2017-2015-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2017-2015-F contains materials concerning Anna Chennault.

The White House Office of Records Management (WHORM) Alphabetical Files contain correspondence concerning the Organization of Chinese American Women.

The WHORM Subject File categories contain correspondence; memoranda; news clippings; and brochures related to gifts to President and Mrs. Bush, the commissioning of a stamp in honor of General Claire Chennault, and the transmittal of a letter from a young girl in the Philippines.

The Staff and Office Files contain correspondence, memoranda, and resumes. There are letters from Congressmen and Mrs. Chennault concerning her desire to work in the administration.

The Vice Presidential Records contain memoranda, forms, and correspondence concerning Mrs. Chennault's membership on the President's Export Council as well as her role in the Republican Party.
