Access

Collection is open to all researchers. Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, July 2019. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in three collection areas—Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; and Federal Records. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.

Related Collections

Related material may be found in FOIA request 2009-0785-F entitled "Selected Records on the European Community;" 2009-0791-F entitled "Selected Files on the European Union;" and 2010-2612-F entitled "Records on the European Strategy Group."

Scope and Content

The materials in FOIA 2018-0885-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2018-0885-F contains materials from agencies and individuals concerning the European Community.

The WHORM Subject File categories contain correspondence to and from the White House from members of the public, government officials, and interest groups regarding the EC.

The Staff and Office Files contain correspondence, press releases, papers, and reports. There are a number of records concerning the development of trade relations with the European Community as well as Uruguay Round. There are papers, talking points, and memos concerning meetings between the United States and EC leadership, European Common Market, Maastricht, energy, and the role of Europe in a post-Soviet world. There are a number of EC press releases and publicly released documents included in the NSC Staff files. There are also papers and talking points related to meetings and with EC officials. Further topics discussed in these records are the European Monetary Union (EMU), European Strategy Steering Group, and Western European Union (WEU).

Federal Records files contain records concerning meetings attended by a staff member from the Office of Consumer Affairs.
