Access to Bush Presidential Records, Bush Vice Presidential Records, and Quayle Vice Presidential Records is governed by the Freedom of Information Act (FOIA)(5 USC 552 as amended) and the Presidential Records Act (PRA)(44 USC 22) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, July 2019. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in seven collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Name Files; Bush Vice Presidential Records: Subject Files; Bush Vice Presidential Records: Staff and Office Files; and Quayle Vice

Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.

Scope and Content

The materials in FOIA 2018-0937-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2018-0937-F contains materials from agencies and individuals including the United States Information Agency (USIA) which is responsible for the U.S. government's overseas information and cultural programs; and the Voice of America (VOA) and Radio Marti, which are programs under the jurisdiction of the USIA. During the Bush administration, the directors of the USIA were Bruce Gelb and Henry Catto.

The White House Office of Records Management (WHORM) Alphabetical Files contain letters between Paul Weyrich and the White House.

The WHORM Subject File categories contain correspondence; memoranda; news clippings; and brochures from the general public, Congress, and the Bush administration. Topics covered by these records include Paul Weyrich and the Free Congress Foundation, Robert Kriebel, International Policy Forum, Council for National Policy, the American University in Moscow, and the movie "Russia House."

The Staff and Office Files contain correspondence, memoranda, and publications maintained by individual staff members and offices. These files contain records related to Paul Weyrich and the Free Congress, the appointment of Robert Kriebel to the Citizens Democracy Corps, and the White House screening of the film "Russia House."

The Bush Vice Presidential records primarily contain invitations for President Bush to participate in events with the Council for National Policy and the Free Congress Foundation. There is also information concerning a meeting with New Hampshire Governor John Sununu and Paul Weyrich.

The Quayle Vice Presidential Records contain schedules and memos related to events in which Vice President Quayle participated for the Council for National Policy and the Free Congress Foundation.
