Provenance

Official records of George Bush's presidency and vice presidency are housed at the George Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Processed By

Staff Archivists, August 2019. Previously restricted materials are added as they are released.

System of Arrangement

Records that are responsive to this FOIA request were found in seven collection areas—Bush Presidential Records: WHORM Alphabetical Files; Bush Presidential Records: WHORM Subject Files; Bush Presidential Records: Staff and Office Files; Bush Vice Presidential Records: Name Files; Bush Vice Presidential Records: Subject Files; Bush Vice Presidential Records: Staff and Office Files; and Quayle Vice Presidential Records: Staff and Office Files. As policy, WHORM Alphabetical Files and WHORM Subject Files are processed at the document level. Staff and Office Files are processed at the folder level, that is,

individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at <http://bushlibrary.tamu.edu/research/find/whorm/whorm.html>.

Please note that a single asterisk "*" indicates that the category is entirely processed and open.

Related Collections

Related material may be found in FOIA request 1999-0311-F entitled "National Prayer Breakfast," and 2009-0705-F entitled "Kenyan Government Ministers/National Prayer Breakfast 1990."

Scope and Content

The materials in FOIA 2018-0942-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2018-0942-F contains materials from agencies and individuals related to the National Prayer Breakfasts as well as other events that include the term "prayer breakfast."

The WHORM Alpha and Subject Files categories contain correspondence concerning invitations and commentary from interest groups and members of Congress, as well as responses from the President and other White House staff.

The Staff and Office Files contain correspondence and schedules concerning events surrounding the National Prayer Breakfast.

The Bush Vice Presidential Records contain correspondence and schedules concerning Vice President Bush's participation in the National Prayer Breakfast and related events. There is also included the VP Alpha File for Senator Strom Thurmond that contains a large amount of correspondence between the Vice President Bush and the Senator on a number of different topics.

The Quayle Vice Presidential Records contain schedules and correspondence related the Vice President's appearance at the National Prayer Breakfasts in 1990 and 1991 and the National Student Leadership Breakfasts of 1991 and 1992
